

1. **Who can enter?** Players' Club members who are 18 years of age or older with a Players' Club card.
2. **When?** Fridays in June (1,8,15,22,29) 2018 from 5pm – 11pm. ("Promotional Day").
3. **Where?** Winner's names will be announced over the PA system and the winner must report to the Players' Club within two (2) minutes.
4. **How?** Fridays in June, Players' Club members who are actively playing with their Players' Club card properly inserted in any slot machine from 5pm to 11pm on a Promotional Day will have a chance to be randomly selected to win a prize. One (1) winners will be selected hourly between 5pm and 11pm and their name will be announced over the PA system. Announcements may not be heard in all areas of the facility. The winners have two (2) minutes to report to the Players' Club.
