

1. **Who can enter?** Players' Club members who are 18 years of age or older with a Players' Club card.
2. **When?** Mondays in September (10,17,24), 2018 from 2pm – 6pm (each a "Promotional Day").
3. **Where?** Winners will be announced and must report to the Players' Club within two (2) minutes.
4. **How?** Players' Club members who are actively playing with their Players' Club card properly inserted in any slot machine from 2pm to 6pm will have a chance to be randomly selected to win. Five (5) times between 2pm to 6pm approximately one (1) winner's name will be selected each hour and their name will be announced over the PA system. Announcements may not be heard in all areas of the facility. The winners have two (2) minutes to report to the Players' Club. A member who is unable to report to the Players' Club within two (2) minutes may, within the two (2) minutes, contact a member of the gaming floor staff who will make radio contact with the Players' Club to make the winner's presence known. At the conclusion of the two (2) minutes, if the winner has not reported to the Players' Club or contacted a member of the gaming floor staff, and presented valid photo ID, the selection becomes invalid and the name of another random winner will be selected. The process is repeated until a valid winner is eligible to receive the prize.

Except for the 6PM Valid winner, who will receive the final envelope remaining.

On Monday, September 24, valid winners will automatically have the chance to select one (1) of the five (5) envelopes from a basket that either consists of: ten (10) \$5 New York Lottery Scratch off Tickets; ten (10) \$5 New York Lottery Scratch off Tickets; fifteen (15) \$5 New York Lottery Scratch off Tickets; twenty (20) \$5 New York Lottery Scratch off Tickets; twenty-five (25) \$5 New York Lottery Scratch off Tickets. Except for the 6PM Valid winner, who will receive the final envelope remaining.

A designated Players' Club representative will open the envelope the member has selected and inside of the envelope will be a paper stating: the total number of tickets and total amount of Scratch-Offs. The Players' Club representative will communicate with the winning member and surveillance the envelope number and amount of scratch-off tickets won. The representative will count out the tickets for the guest. After each valid winner has selected an envelope from the basket, it will not be replenished; the last valid winner will receive the last envelope.

There will be five (5) winners each Promotional Day which totals fifteen (15) winners over the Promotional Period. If a winner's name is selected after having received a prize on a Promotional Day, the selection will be invalid and another winner will be selected.
